I understand that Hartwell Riding Stables has strict weight restrictions on their horses and ponies for the welfare of the animals and reserve the right to refuse any child or adult obviously over this weight limit. (Weight limits for all ponies vary, our maximum weight limit is 11st7lb / 73.2kg / 161lb). I confirm that the weight I have stated above for myself or my child is accurate and true, and if my or my child's weight changes to above the weight limit while riding at Hartwell I will inform them.	
Data Protection Act 1998. Statement: I understand that the information I have given will be held in accordance with the Data Protection Act 1998 but may also be made available to insurers and other concerned parties in the event of injury or accident. I understand that I must obey the instructions of the staff and Instructors and must comply with the Health and Safety requirements of the establishment.	
I reserve the right not to ride a horse allocated to myself or my child and may request a change of instructor, however lessons will still be chargeable if changes are requested but cannot be fulfilled resulting in lesson cancellation within the 24 hours cancellation period.	
In the event of accident I will allow the establishment to check over myself or my child and administer first aid if necessary. If I leave or remove my child this is entirely at my own risk.	
I acknowledge that RIDING AND BEING ON A YARD AROUND HORSES IS A DANGEROUS SPORT AND ACTIVITY AND HOLDS POTENTIAL DANGER. ALL HORSES AND PONIES MAY REACT UNPREDICTABLY ON OCCASIONS.
